CAS Annual Meeting

Congregation Ahavath Sholom's annual meeting took place at our North Street synagogue on Sunday, July 14. An excellent turnout of members attended and heard a review of the past year from moderator Alison Adams-Weinberg.

Thanks were given to Arthur Hillman and Linda Josephs for their years of service on the Executive Committee and Board of Directors. Those members who are leaving the Board (Irene Goldman-Price, David Scribner, and Arlene Shapiro) were recognized for their fine work, and the Religious and Spiritual Life Committee (Brenda Butler, Lisa Chamberlain, Chairman Harold Schrager, John Slote, and Rabbi Cohen) received thanks for their continued dedication to the congregation's spiritual life.

A report by the Nominating Committee chaired by Joan Burkhard followed. Board members whose terms expired (Dan Burkhard and Ilene Spiewak) were renewed. Linda Geffin and Debbie Slater, two new candidates for the board, each gave a summary of their backgrounds and professional experience and were elected by a vote of those present. The Building Committee (Dan Burkhard and Jane Stepman) continues its work and the formation of a new committee, the Development Committee, consisting of Joan Burkhard as Chairperson, Sandra Flannery, Linda Josephs, Susan Weinstein, and Keren Weiner as a consultant, was announced.

The RSL report was delivered by Harold Schrager confirming the dates of our High Holy Day services at the Berkshire South Community Center. The agreement with Rabbi Jennifer Rudin to serve as our Interim Rabbi from November 1, 2024 to June 15, 2025 has been drawn up and approved by all parties.

The financial health of our congregation was discussed by current treasurer Arthur Hillman and our former treasurer and current consultant Dan Burkhard. A budget for the fiscal year 2024-2025 was presented along with figures from the past two fiscal years for comparison. After three years of running a deficit, our goal is to achieve a balanced budget by the end of this fiscal year. It was announced that Irene Goldman-Price and Arlene Shapiro will continue to serve as members of the Finance Committee. Membership invoices have been sent out to congregants and it was mentioned that members who can contribute more than their billed dues would be of great help and support to the congregation.

A Search Committee report was given by Alison Adams-Weinberg. This committee currently consists of John Slote, representing the RSL, Daniel Schenker, representing the Executive Committee, and Jamie Horowitz, representing the general congregation. A formal application will be sent to Rabbi Elliot Skiddell of Reconstructing Judaism by the end of August.

A Survey Committee was announced consisting of Irene Goldman-Price and Jayne Benjulian to formulate a series of questions to present to congregants to help guide the rabbinical search and our future planning. The committee will summarize the results and present it to the search committee.

Dan Burkhard gave a brief explanation of our door video equipment and procedures along with some other security details.

Linda Josephs reviewed this year's Creative Arts offerings and mentioned on-going and new programs for the coming year.

Rabbi Cohen made some final comments in this, her final Annual Meeting as our Rabbi.

The business part of the meeting was followed by an impressive potluck dinner coordinated by Debbie Slater, on the second floor of our historic building.

A talk by Toby Anne Axelrod: "Stories My Grandfather, Rabbi Jacob Axelrod, Told Me"

On Sunday July 21st at 2:00 PM, Toby Anne Axelrod, the granddaughter of Rabbi Jacob Axelrod, spiritual leader of Congregation Ahavath Sholom from 1927 until 1984, gave a talk about the life of her grandfather and her memories of growing up as a part of Congregation Ahavath Sholom. A large audience attended the event that was held at the South Berkshire Friends Meeting House on State Road in Great Barrington. A number of attendees then proceeded to North Street to tour the synagogue.

Ms. Axelrod writes, "My zeyde, an Orthodox rabbi, found the job at this small synagogue in Great Barrington, MA in 1927. He answered an ad in a Jewish newspaper two years after he came to America and was the congregation's Rabbi for 60 years until 1984. He also served as the religious leader and shochet, kosher butcher, of Great Barrington's small Jewish community. The synagogue building had been sold to a Jewish junk dealer (Mr. Broverman) who had made a promise to open a shop at that location. Instead, to the chagrin of town officials, the little, white, two-story frame house became Ahavas Sholom - Love of Peace Synagogue." The historic building on North Street in Great Barrington is still the home of the congregation and is the longest synagogue building in continuous use in the Berkshires.




Louise's Garden Photographs by Arthur Hillman


